Coverage Report

November 1st to November 30th 2022

We compiled forty-three publications related to the bilateral relationship between Mexico and the United States during the period from which 63% were written by Mexican think tanks, while 37% of the publications were published by United States think tanks. The *Consejo Mexicano de Asuntos Internacionales* (COMEXI)¹ was the leading institution with twenty-one publications, followed by the Mexico Institute with six publications and *México Evalúa* with three publications.

The main topic was **democracy**, mainly due to the midterm elections in the United States on November 8 to renew 435 seats in the House of Representatives, 34 senators, and 36 governors. The Republican party was expected to win by a considerable margin. However, the Democratic party obtained a favorable result. During this time, think tanks analyzed how different scenarios affected the relationship between Mexico and the United States. The Democratic party had on its agenda to prioritize human rights and a more flexible immigration policy, as well as climate change and concerns about the politicization of the judicial system in Mexico. The Republican party, on the other hand, places issues of organized crime, drug trafficking, and immigration at the center of its agenda. Both parties were concerned regarding Mexico's energy policy. Furthermore, the topic of democracy also addressed the controversial electoral reform proposed by President Andrés Manuel López Obrador. He intends to change the National Electoral Institute (INE) into a new agency whose members are elected by citizens rather than Congress, the President, and the Supreme Court. This proposal generated a wave of protests on November 13 in several cities.

The second most relevant topic was the **institutional relationship** since this year marks the 200th anniversary of diplomatic relations between Mexico and the United States. The publications mentioned some significant advances for both countries during these times; among them were the growth of bilateral trade by 900% in the last 30 years² and the bicentennial framework, where both countries share a vision on border security and immigration. Also discussed was the opportunity to strengthen the bilateral relationship, where it is fundamental to have a clear institutional framework, clear rules for both countries, and verification mechanisms for projects and commitments.

Subsequently, **international trade** featured the strengthening of North America as a trading bloc and the automotive industry regarding rules of origin, economic impact, and competitiveness. Regarding security and governance, the debate focused on the fight against drug and arms trafficking, mainly on the illegal trade of fentanyl and the rising deaths caused by it, the growing military presence in Mexico, and femicides. The next topic is **immigration** and the U.S.-Mexico border crisis. These were followed by the **economy**, where remittances continue to be at a record high. Some articles regarding **education** and the **labor market** were also published, focusing on opportunities for Mexicans to study in the United States and take advantage of the STEM classification. The labor market article concentrates on attracting and retaining foreign talent in Mexico. Finally, while the COP was held in Egypt in mid-November, not much was published about the bilateral relationship and the environment.











Topics Covered

The chart above shows the most popular topics covered in each report over time. In this period, we can see that democracy and institutional relations rose in interest compared to the previous month. This is due to the midterm elections in the United States, in which the impact on the Mexico - United States relationship and its possible implications and the protests in Mexico regarding the electoral reform proposal by President Andrés Manuel López Obrador. Among the issues that have remained constant over time are international trade, institutional relations, economy, security and governance, and migration.
